# 1) Refresher of approved Executive Videocall Minutes of May 2, 2022

# 3) Board Membership and Composition Working Group Document with emphasis on Appointment/Reappointment Process.

Executive reviewed the material prepared by the working group and approved it. Documenting the procedures for appointing and reappointing members was acknowledged as best administrative practices.

# 4) Strategic Directions & Operational Business Plan Working Group Document

The Executive reviewed the document and accepted the general strategic commitments as identified but recommended the Operational Business Plan more clearly be aligned with the Strategic commitments and to the extent possible, identify linkages with the Ministry's strategic plan.

# 7) Review of Expansion of MOTI Gravel Pit referral From FrontCounter BC

Executive carefully examined this item and although concluded the existing gravel pit was being managed well, Executive concluded that advice back to FrontCounter BC would be to recommend the expansion of the gravel pit into the protected area immediately South of the existing pit not proceed for the following reasons:

- The expansion impinges into the Protected Area with no obvious benefits to support the impingement
- This site is the trail head of a popular trail accessing the Muskwa-Kechika Management Area which could be detrimentally impacted if the area was included in the gravel pit operations, and
- The Executive is not concerned with the rest of the expansion: only the area South of the highway for the reasons noted above.

# **ACTION**

Phil to draft a response letter for Stephanie to send to FrontCounter BC.

On behalf of the Board, Executive concluded that an iconic photograph of the M-KMA for Minister Osborne would be appropriate as an expression of gratitude for her enthusiasm for the management area.
