Opening Address: Tom Briggs, M-KAB Chair -

#### 1) Investigating the Effects of Wind Power in the M-KMA

This was a presentation from Wildlife Infometrics, project contractor, followed by questions and answers. (Power point presentation to be posted on Board member web pages after meeting)

M-K members further will discuss the presentation and project on Tuesday afternoon. This project has a May 30<sup>th</sup> finalization date.

#### 1) <u>Restoration and monitoring in the M-KMA –Development of a</u> framework for all resource activities in the M-KMA

This was a presentation from Doug Russell, Green Tree Resources consulting which was followed by questions and answers.

8:30 am:

 M-K Conservation Assessment Project – This project was initiated and led by Yellowstone to Yukon, Wendy Francis/Jim Pojar presenters. (The M-KAB provided funding for this project)

After presentation and discussion on the presentation and project took place, the project final deliverables are targeted to be for end of May.

This concluded the public portion of the May M-KAB meeting.

11:00 am: The M-K Advisory board invited 4 industry representatives attending this meeting to speak regarding their industry and perspectives on the M-KMA.

The Advisory Board acknowledge that there is a lack of industry representation on the Board and encouraged industry to step up and participate. All 4 representatives would accept appointments to the Board. Government supported this and recommended the M-KAB put forth a letter to Minister Thomson stating this request for his action.

11:45 Resources North Association – presentation by Melanie Karjola and Phil Zacharatos

This presentation was highlight to the M-KAB about Resource North Association, who they are and what they do and determine if a possible partnership with this association could be entertained for the future.

1:15 PM - Review the final part of the agenda to complete Board business.

Board made a request that John Cavanagh, Assistant Deputy Minister for Ministry Forests Lands and Natural Resource Operations, speak to the Board directly on government's current view of the M-KMA/M-KAB and future;

John spoke candidly to the Board members at this meeting and made some recommendations for them to work on:

- Make specific request to current Board members to step up and participate and if not, then request government to make changes with membership, get those wanting to be involved.
- 2) John was encouraged with industry reps attending this meeting, keep industry on side with what you are doing and provide letter to Minister to appoint those attending this meeting and work with them over the next 6 months to get them involved and industry interested in the M-KMA.
- Expressed concern with this meeting about the lack of First Nations participation and values with the M-KMA, asked if this is usually the case with Board meetings.

#### M-KAB Operational Budget and M-K Trust Fund:

There was to be tabled a discussion on the remaining funds in the RNA account (est \$140k at end of April) and how the board would utilize these funds. Discussion broke down due for several reasons, that the M-K trust fund Expenditure Plan (which was to fund this meeting) had not gone forward, government at the time of this meeting had not provided the amount available for

the Board's use. There was uncertainty at this point whether the operational funds could be carried over past March 2012.

With this all this uncertainty, there was no consensus on how to prepare an operational budget.

The M-K trust fund Expenditure Plan was deferred to the Executive once the final amount in the account was known and provided to the Advisory Board.

#### Advancing the final deliverables of the project presented at this meeting:

There was no consensus on how to implement/advance the final deliverables for these projects. Was deferred to the All committee meetings.

#### Briefing on the work undertaken by The Governance Group (V Battistelli)

Vince touched bases on his work, the Executive's discussion with him on what was required and his attending this meeting. He advised he would table his report by the end of May with a final conference call with the Advisory Board Executive by middle of June

Chair Tom Briggs concluded the meeting with a round table invite to Board members to provide their concluding comments and observations, thanked members for attending.

Next meeting was to targeted sometime in the last two weeks of October 2011.
