Thanks for a good meeting today. After further thought on the matter of closure to this plan, Scott and I have agreed to a one time only meeting of the PEG to review the final draft of the plan. That will take place after all of the MK Parks committee has provided their input and our staff have had a chance to review the comments, make changes, etc. Scott will send out the draft before the meeting to those PEG members who are still around and a meeting will be arranged to finalize this draft. If all works well, the meeting will be held this spring.

With respect to the issue of firearms in parks during the off hunting season, this issue is being looked at by our policy team in Victoria. As I explained to you today, we will not be putting anything in the park plans as the Parks Act and regulations does prohibit the carrying of firearms in Parks outside a hunting season without a permit. If the MK Board wishes to send a recommendation on changing the act or regulation, they should do so via myself.
